

# Theatre Arts Dance Company 1 & 2

## **2021-2022 Informational Packet**

Theatre Arts Dance Companies are designed to provide dedicated dancers with the opportunity to perform, compete, and rehearse in a pre-professional atmosphere in addition to their weekly classes. This select group will develop a good work ethic, discipline, and advanced dance training over the year. They will also receive pre-professional training all while gaining an extended dance family and fun memories to last a lifetime! Our main focus is to develop strong, competitive, well-rounded teams of dancers and performers and provide them with extensive training opportunities that go beyond what they receive in their normal technique classes.

### **Company Structure**

**TADC 1:** TADC 1 is a group of intermediate to advanced dancers ages 7-18 that are ready to take their dance training to the next level! Dancers must be 8 years old by January 1<sup>st</sup>, 2022. Participation in TADC 1 is by audition only. This is a great gateway program to TADC 2 for dancers that are interested in competing but not quite ready for the full commitment of TADC 2. Dancers must be enrolled in ballet and jazz in addition to their weekly TADC 1 rehearsals. TADC 1 dancers ages 11 & up are required to take one additional class which can be tap, jumps and turns, lyrical, contemporary, musical theatre, Broadway Dance, or hip hop. The required classes must be taken in both the summer and fall sessions. TADC 1 dancers will have the choice in competing in a maximum of 1-4 company dances for the year at 3 **local** competitions. They will have one weekly 30 minute company rehearsal per dance they are cast in.

**TADC 2:** TADC 2 is an elite group of dancers ages 7-18 that are ready to compete and train at an advanced, pre-professional level in a variety of different dance styles. TADC 2 will compete in 4-5 regional competitions throughout the year in Tulsa, Dallas, and/or Kansas City and a Nationals competition in New York City over the summer. A maximum of 3 of these may be out of town. TADC 2 dancers will have the opportunity to compete in a minimum of 2 or a maximum of 6 dances in a variety of different dance styles including contemporary, jazz, tap, ballet, lyrical, ballroom, musical theatre, or hip hop. Theatre Arts brings in some of the most elite and sought after choreographers to set choreography on TADC 2 each year. Dancers must be enrolled in ballet, tap, jazz, and one additional class (Can be contemporary, hip hop, lyrical, jumps & turns, musical theatre, Broadway dance, or ballroom). TADC 2 will be competing at the following competitions for the 2021-2022 season: Nuvo Tulsa (Oct. 29-31), NYCDA KC (Nov. 19-21), and 2-3 additional regional competitions as well as NYCDA Nationals June 30<sup>th</sup> - July 8<sup>th</sup>. (All dancers will not need to attend Nationals for the entire event, most will only be there for 4-5 days).

\*Auditions for BOTH companies will take place at the same time. On the dancer's audition information form they will select whether they are only interested in TADC 1 or either company depending on the directors' recommendations.

### **Parent Meeting**

There will be a parent meeting at Theatre Arts on Friday, May 14<sup>th</sup> at 5:30 pm for all interested families. There will also be a zoom meeting option for families that are not able to attend. Please let us know if you would like the zoom link.

### **Auditions**

Auditioning dancers should bring ballet, tap, and jazz shoes and be prepared to learn 2-4 short dance combinations in a variety of different styles. Pre-registration through the Theatre Arts family portal is required

and there is a \$10 audition fee for all auditioning. Dancers should come with the dancer audition form (the last two pages of this packet) already filled out.

Auditions will take place at Theatre Arts on Wednesday, May 19th. The audition schedule is listed below:

Ages 13 & up	6:00 - 6:45

\*All ages are as of January 1<sup>st</sup>, 2022.

## **Time Commitment**

**Technique Class Requirements-** Please see required classes listed above for each company. Dancers must maintain a 75% attendance average in their required dance classes.

**Summer Rehearsals & Choreography-** Students will learn the majority of their choreography for the year over the summer. Dancers will learn an entire dance in one or two rehearsal days. We will do our best to work around student's conflicts that are submitted with their audition forms. Most choreography sessions will take place on Wednesday afternoon/evenings. For some guest choreographers, rehearsals will take place on Fridays or Saturdays or in first two weeks of August in the break between Theatre Arts summer and fall sessions. A full rehearsal schedule for June will be sent out by June 1<sup>st</sup> and the full schedule for July will be sent out by June 30<sup>th</sup>.

**School Year Rehearsals-** Most groups will rehearse on Wednesday afternoons (4:00 – 7:30). Some additional numbers (trios, small groups, etc.) will rehearse on Friday afternoons and/or Saturday mornings. Each dance will have a weekly 30 min. time slot to rehearse throughout the school year. Please take the time to thoroughly fill out your availability and how much rehearsal time you are willing to commit on your dancer information sheet so that we can cast accordingly.

Students who do not complete their commitment to the entire season after signing their company contract for reasons other than family emergency, family moving, or serious injury or illness will be required to pay a \$300 exit fee to compensate for additional rehearsal time, changing entry fees, etc. in addition to paying all costume fees for dances they were already cast in. Please be SURE that this is a commitment your family is ready to make before auditioning. Company members accounts will not be refunded for any company fees should they choose to not fulfill their company obligations mid year.

## **Financial Commitment**

While Theatre Arts makes every effort to keep company costs to a minimum, being a part of TADC is definitely a financial commitment. We offer several fundraising opportunities throughout the year, as we want as many of our students as possible to be able to experience being a part of this dynamic group.

### **Monthly Rehearsal Fees**

All Company Members will pay a rehearsal fee of \$15 per month per company *group* dance they are cast in. All company members will pay a rehearsal fee of \$25 per month per company *duet/trio* they are cast in. These monthly rehearsal fees will begin being charged in August in addition to their class tuition.

### **Choreography Fees**

There will also be a \$50 choreography fee for each group dance, a \$100 choreography fee for each trio, and \$150 choreography fee for each duet choreographed by Theatre Arts faculty. All TADC 1 pieces will be choreographed

by Theatre Arts faculty. These fees will be due by the date of the choreography session. Some TADC 2 pieces will be set by guest choreographers. For some guest choreographer's pieces, there will be an additional choreography fee. All TADC 2 dancers invited to be in the guest choreographer's piece will have the choice to participate and pay the choreography fee or to decline that additional routine.

### **Competition/ Convention Fees**

Competition Entry Fees are approximately \$50-\$60 per group number, per competition.

Convention Class Fees are approximately \$250- \$300 per convention.

Competition fees are due 60 days before each competition. Exact dancer competition fee breakdowns will be sent out in August along with the competition schedule for the year.

### **Costumes**

Each company group dance students are cast in will equal an additional costume fee. Company costumes have had a price range from \$50-\$150 each. We will make all efforts to keep costs at a minimum while still providing competitive, high quality costumes. A \$100 costume deposit will be due by June 1st along with the company member's signed contract. This nonrefundable costume deposit will be applied to the dancer's TADC costume balance. ***New- costume balances will be due in two installments in July and August this year!***

### **Optional Purchases**

We will provide opportunities for our company members to purchase dance bags, sweats, and other company related items in August. All of these purchases remain OPTIONAL.

## **Fundraising**

There will be fundraising opportunities throughout the year for all company members. While we welcome any and all fundraising ideas from parents, the implementation of all company fundraisers using the studio name must be done by Theatre Arts or after receiving approval from studio directors. ALL company families are welcome to participate in ALL fundraisers. If you have an idea for a new fundraiser or are interested in organizing a new fundraiser please let us know!

## **Solos**

All TADC 1 & 2 members will have the opportunity to purchase solo choreography by any of the Theatre Arts faculty or our guest choreographers. All solo music must be pre-approved by directors. Any dancers wishing to compete a solo during the season must be enrolled weekly or every other week private lessons with a Theatre Arts faculty member to be eligible to compete their solo. Theatre Arts will hold auditions with a guest judge prior to competition registration for any competitions which limit the number of solo entries a studio may bring. All company member's accounts must be current to be eligible to compete a solo.

## **Company Contracts**

Our Company Contracts with statutes and limitations mirror professional contracts will prepare the students for work in the professional dance world. We want to make sure that all students are committed for the benefit of the team. When one student drops their commitment mid-year it has a detrimental effect on the remaining members of the team. These contracts are mainly for the protection and best interest of the group. There is a parent contract and a company member contract attached to this packet. Please take the time to read through these thoroughly so that any questions can be discussed prior to the start of the season.

## 2021–2022 Theatre Arts Dance Company 1 Student Contract

These are the policies and procedures of the Theatre Arts Dance Company. Each student and parent must agree to abide by these terms in order to participate in the 2021–2022 Theatre Arts Dance Company. By signing this contract below, both parties agree to its contents, which are as follows:

### **Attendance**

- Company members are permitted **3 excused** absences from each number’s rehearsal per semester. Excused absences must be requested by email **prior** to the rehearsal. Any absence that is not properly communicated prior to the rehearsal will not be considered “excused” and may result in immediate dismissal. Extenuating circumstances will be considered on a case by case basis. However, any absences exceeding the allowed 3 excused may result in the member being removed from specific numbers or dismissed from company entirely. These absences will also be taken into consideration for the following year’s company invitations.
- Company members must submit all summer conflicts with their dancer information sheets & contracts. The summer rehearsal schedule will be set around these conflicts so any additional absences are not excused.
- Company member acknowledges the importance of their individual technique classes. Company members with less than 75% attendance in their required technique classes may be removed from company or specific dances at the director’s discretion. This will be strictly enforced.

### **Commitment**

- Company member agrees to attend all rehearsals, conventions, and competitions and to follow all company rules including dress code, classroom etiquette, and respect for all instructors and team members.
- Company members may not be cast in every dance that they would like to be cast in. They agree to respect the decision of the directors.

### **Attitude**

- Company members acknowledge that individually, they play a vital role in the success of the entire team. Therefore, each company member agrees to approach each class and rehearsal with an exemplary attitude and work ethic. Consistent failure to demonstrate this behavior may result in a company member’s dismissal.
- Parents and company member acknowledge the privilege each member has to represent Theatre Arts as a participant of its dance company. Therefore, parents and students agree to conduct themselves in and outside of the studio in a way that humbly but proudly exemplifies the select few who are chosen to represent Theatre Arts.

### **Dress Code**
